

SECOND-GENERATION STUDIES OF THE CHINESE MARITIME CUSTOMS (CMC): NEW RESEARCH ON MISCELLANEOUS REPORTS AND RECORDS PUBLISHED BY CMC

INTRODUCTION

Research into the miscellaneous series of reports and records of the Chinese Maritime Customs (CMC) listed in this article constitutes a new approach toward the study of the custom service, which this article categorizes as “second-generation studies.” Besides research into the miscellaneous series of reports and records, second-generation studies also include letters, diaries, reminiscences, interviews, and the biographies written by family members and relatives, to allow scholars to piece together valuable ethnographic records of their social lives, travels, hobbies, and career activities while in China. Many customs officials continued to maintain their involvement with China even after their retirement from the service through their involvement in academia. They became crucial in the pioneering of new fields, such as comparative cultural history.

After the 2010's, there are a series of publication on the custom history. They focused either institutional history of custom administration or personal history of custom workers by using diaries, letters, memoirs, and photographs. We can call these works as a second generation of custom studies. They are:

There are three main roles in the second generation studies. Firstly, new study will re-examine the historical background of so-called Open Port System which has been characterized as the result of the pressure by foreign powers. Here in this paper, newly classified groups of open ports are listed in the **Table 1**.

Secondly, new study will re-examine the works by the first generation on the CMC which has been focused on trade reports and trade statistics. Here **Table 2** shows the historical transformation of method of collection of tax and ways of arranging statistics in the custom's report

from each custom's Commissioner to Robert Hart, the Inspector-General (IG) of Customs at Peking. **Table 2** also shows major historical changes of the method to make statistics in all customs under the same standard.

Thirdly, new study will unveil varieties of custom publications with direct and indirect relations with custom works (**Table 3**).

In general, CMC documents are grouped into seven series altogether and there are also various individual publications. Seven series are as follows:

- I. Statistical Series (Trade Returns, Trade Reports, Decennial Reports, etc.) (See **Table 2**)
- II. Special Series (Specialist works on specific topics) (from II to VII, See **Table 3**)
- III. Miscellaneous Series (Explanations about merchandise, etc.)
- IV. Service Series (Service lists, details of duties, etc.)
- V. Office Series (CMC business as a whole)
- VI. Inspectorate Series (Circulars issued by the IG and others)
- VII. Postal Series

Among these series of publication, we can find varieties of socio-economic, socio-cultural, and personnel documents and reports beyond formal custom reports and trade statistics. Through letters and diaries, we can also find individual life of custom workers before and after their work in the customs.

The following Tables 1 and 2 are arranged by author and Table 3 is assessed by author from various published lists during 1858–1940 from CMC.
